2. PRESENTATION OF EFFECTIVE AND ROLL BACK TAX CALCULATIONS FOR 2017 TAX YEAR.
3. APPROVAL OF THE 2017-2018 ELECTION JUDGES PROVIDED BY THE REPUBLICAN AND DEMOCRATIC CHAIRS WAS MADE BY A MOTION FROM COMMISSIONER SMITH AND SECONDED BY COMMISSIONER WORSHAM. MOTION CARRIED. (Commissioner Chamberlin abstained from item).
4. APPROVAL OF RESOLUTION REGARDING 2017 TAX ROLL RECEIVED FROM TRINITY COUNTY APPRAISAL DISTRICT IN ACCORDANCE WITH PROPERTY TAX CODE 26.04 WAS MADE BY A MOTION FROM COMMISSIONER CHAMBERLIN AND SECONDED BY COMMISSIONER SMITH. MOTION CARRIED.
5. A BUDGET WORKSHOP WAS HELD. BUDGET ITEMS WERE DISCUSSED. NO OFFICIAL ACTION WAS TAKEN BY COMMISSIONERS ON THIS ITEM.
