# AN IMPORTANT MESSAGE TO ALL ON-SITE SEPTIC INTERESTED PARTIES

Matagorda County Commissioners' Court on September 25, 2006 approved a new county order regulating on-site septic facilities (OSSF). Septic system design, construction, location, installation, alteration, extension, repair, operation, maintenance, and permitting are regulated under rules formulated and adopted by the Texas Commission on Environmental Quality (TCEQ), Chapters 285 and 366, and by Court Order of Matagorda County Commissioners' Court. In Matagorda County, these rules are administered and enforced by the Matagorda County Environmental Health Department (MCEHD).

It is the policy of MCEH to assist the county's citizens in obtaining safe and adequate on-site sewage facilities (OSSF's); to minimize the exposure of Texas citizens to the disease transmission potential of human and domestic waste; to minimize the contamination of drinking water supplies and hazards to the state's recreational areas; and to reduce the potential for surface groundwater pollution.

The updated OSSF rules for Matagorda County contain three amendments new to the approved court order. The amendments make the rules more stringent than Chapter 285 of the Texas Administrative Code. The amendments are as follows:

- a. A permit will be required for all On-Site Facilities, regardless of the size of the lot or acreage onto which they are installed.
- b. All construction of any type of on-site sewage facility shall be by a Registered Installer. There shall be no property owner/homeowner installation unless the property owner/homeowner is also a Registered Installer.
- c. Testing and reporting of On-Site Sewage Facilities must be performed by an approved maintenance company, regardless of population.

The following attached pages are designed to provide an OSSF owner some basic and essential information about the subject. Anyone interested in additional information is encouraged to contact our agency. We have trained professionals on our staff to provide free information to you. In addition, we provide permits to system owners at a reasonable fee which includes inspection services and a license to operate the system as required by state law.
